The meeting was called to order at 7:00 pm with Mayor Zeger leading the Pledge of Allegiance. Public Comment was opened.

Mr. Heefner asked Council what their plan was for the Borough. He asked for a show of hands as to what the New Direction of Council was moving toward.

Jeff Main spoke that the Borough needs to have better communication and have a TEAM Concept.

Mr. Heefner asked what the New Direction was. He stated that the Borough Manager was told that Council was moving in a New Directions when she was placed on administrative leave and who got together to formulate a plan. He stated that Council is wasting tax payers money and it is time for Council President to tell the citizens of the Borough what the New Direction is.
